SUSANNA⁵ LAUBACH (*CHRISTIAN*⁴, *JOHAN CHRISTIAN*³ LAUBACH, *JOHAN REINHART*² LAUBACH, *JOHAN CONRAD*¹) was born 24 March 1779 in Allen Township, Northampton County, Pennsylvania^{4,5}, and died 06 December 1853 in Northampton County, Pennsylvania. She married MICHAEL DANNER Abt. 1796, son of MELCHOIR DANNER and ANNA BARBARA. He was born 22 August 1767 in Northampton County, Pennsylvania⁶, and died 24 February 1842 in Northampton County, Pennsylvania.

Notes for MICHAEL DANNER:

Michael inherited the central portion of his father's land, including the homestead. Michael also owned a hotel on the road leading from Mauch Chunk to Easton, which did a brisk business. The place where the hotel was located came to be called Dannersville.

Michael also donated land for a schoolhouse (Danner's School) just 100 yards from his hotel. His own children went to school there.

In 1798, a United States Direct House Tax was assessed on all home owners. For this assessment, Michael, of Moore Township, was assessed for 1 log house that was 34 ft. by 24 ft. and one story tall. The assessed value of the house was \$275.00. (Note: this is the house that Michael's father, Melchior built for his family).

Marriage Notes for SUSANNA LAUBACH and MICHAEL DANNER:

Susanna was only 16 or 17 when she married Michael. Their first child was born just a few months after her 17th birthday. In all, Susanna and Michael had 12 children, ten of whom married and had families of their own. According to census records (1800-1840), the couple lived in Moore township throughout their married life. They belonged to Zion Stone Church in East Allen Township, where Susanna was raised.

Michael died in 1842 at the age of 74. Susanna signed a quitclaim granting the administration of her husband's estate to her sons J. Melchoir and Michael Jr. Around this same time, six of Susanna's children moved to Mercer county, Pa.

Susanna lived alone after her husband's death in a house next to her daughter and son-in-law, Catharine and George Spengler. She died there in 1853. (These notes were taken in part from the Laubach Family Association Genealogy).

Notes for HARRISON DANNER:

In the 1870 Census, it is stated that the value of Harrison's real estate is \$6000 and that his personal estate is worth \$1000. His occupation is listed as farmer. In 1875, when Harrison's father died, he and his siblings inherited a large amount of property. Some of the siblings decided to purchase this land from the estate and the money from the sale was presumably equally divided among the heirs.

Notes for EMALINE ANTRY:

Emaline was only 15 when she married Harrison and 17 when she had her first child, Mary. In the 1910 Census, it states that she was mother to 9 children, only two of whom were still living (William and Malissa). Emaline was widowed in 1896 at the age of 45. She remarried sometime around 1905. Her new husband was Washington Nagle. In 1910, Emaline and Washington were living on Warren St. in the borough of Fountain Hill. Emaline's son, William and his two children were also living there. By 1920, Her daughter, Malissa is also living in the house. Emaline died at home in 1921. She was buried beside her first husband, Harrison, at the Zion "Stone" Church cemetery under the name, Emaline Danner.

Notes for MALISSA L. DANNER:

Malissa Danner never married. On April 16, she was admitted to the Blough Convalescent Home on Market St. in Bethlehem, Pa. She remained there until her death less than two years later. Before she died, her home at 1320 Moravia St. in Fountain Hill was sold to James and Mary King for about \$5,500. The proceeds from this sale were used to pay for her medical care and the fees of the convalescent home.

In her will, Melissa directed that the money left in her estate, which amounted to about \$5,515.00, be left to the following persons: Pearl and Agnes Danner, Erma Troxsell (niece), Alvin Redline (Nephew), Minnie Caskie (niece),

Arline Moser (great-niece), Frank Moser, Esther Vogel (great-niece), Marlin Vogel (great-great-nephew), Joan Vogel (great-great-niece), and Jean Marie Vogel (ditto). An amount was listed for each person, ranging from \$100.00 to \$1,000. each, but because there was not enough money left in the estate to pay the specified amounts, each person received about 2/3 of the amount specified in Malissa's will.

Notes for ALVIN J. REDLINE:

In the 1910 Census, Alvin is residing in the home of his grandmother, Emmaline, on Moravia St. in Fountain Hill. His mother was apparently deceased by this time. It is not known if his father was alive or not. At some point after this census was taken, he apparently went to live with Steward and Annie Zoller as a foster child. It is not known if they were blood relatives.

Alvin apparently never married. At the time of his death, he was living in a home in Hellertown with his foster sister, Reda Stauffer. He worked for Bethlehem steel as an electrician for 32 years.

WILLIAM HARRISON⁸ DANNER (*HARRISON⁷, JOHN MICHAEL⁶, SUSANNA⁵ LAUBACH, CHRISTIAN⁴, JOHAN CHRISTIAN³ LAUBAUCH, JOHAN REINHART² LAUBACH, JOHAN CONRAD¹*) was born 08 April 1870 in Rockville, Lehigh Township, Northampton County, Pennsylvania, and died 13 August 1942 in New Columbia, Union County, Pennsylvania^{19,20}. He married ARAMINDA RAVERT 04 June 1892 in St. Paul's Indianland Church, Northampton County²¹, daughter of HENRY RAVERT and AMELIA COFFIN. She was born 1875 in Danielsville, Lehigh Twp. Northampton County, Pa, and died 19 June 1954 in Bethlehem, Pennsylvania.

Notes for WILLIAM HARRISON DANNER:

According to the 1890 Northampton County census Directory, William, age 20 was living in the village of Cherryville in Lehigh Township. This is probably where he met Araminda Ravert, whom he married in 1892.

After his separation from his wife, William and his two children (Pearl and Erma) lived with his mother, Emmeline, and her new husband, Washington Nagle, in a house on Moravia St. in Fountain Hill. In later years, after his mother and step-father died and his children were in homes of their own, William and his sister Melissa continued to live in the house together. William worked as a clerk at the Steel mills for many years.

William was a member of the Knights of Friendship, Chamber No. 6 and the F. O. E. in Bethlehem. He was also a volunteer firefighter for many years.

William made several real estate purchases in Lehigh county. The first one, in 1912, was a small lot on 16th street in Allentown for the sum of \$300.00. In 1917, he purchased a home on Warren St. in Salisbury Twp. (now Fountain Hill) for the sum of \$2400.00. William's son, Pearl, moved in to the house with his family.

In 1920, William and a man named Jacob Muschko purchased property in Whitehall Township measuring 7,650 sq. ft.

In his spare time, William liked to make wine in the building behind his home on Moravia St. His grandchildren would collect fruit and berries from the many trees and bushes in the neighborhood, as well as dandelions, so that he could make a wide variety of wines.

At the time of his death, William owned the house at 18 Warren St. in which his son, Pearl, was living with his family. In his will, he bequeaths the house to Pearl. He also owned some property in Bethlehem, which he leaves to his daughter, Erma. The lot on 16th St. in Allentown is inherited by Pearl and Erma.

Notes for ARAMINDA RAVERT:

Minnie (Araminda) was born in Cherryville and lived there until her marriage to William. She was the daughter of a Civil War veteran and the granddaughter of a veteran of the Spanish-American War.

Her ancestry was at least half English, as her mother was the daughter of of Horatio Coffin and Amelia Robinson, both of whom were born to English families which had been in America for many years. Minnie's father (Henry) may also have been English.

At the age of sixteen, Minnie married William Danner. They had three children together, George, Pearl and Erma. Their son George died in some type of accident. George's death reportedly placed a great strain on the marriage and Minnie and William separated, then divorced. While the children remained with William, Minnie kept in touch with them.

She moved to South Bethlehem where she is rumored to have been a Madame, taking care of "working girls". Minnie was also a respected midwife who delivered many babies, especially in the Fountain Hill area.

Despite their estrangement, Minnie and William remained on good terms with one another throughout their lives. William even made sure that there would be enough money for burial expenses when Minnie died. Late in her life, Minnie married Charles McGraw. They lived in South Bethlehem.

Notes for PEARL ULYSSES DANNER:

In 1910, Pearl and his sister Erma are listed as the purchasers of a lot adjacent to the one owned by his aunt, Malissa Danner, on Moravia St. in Fountain Hill. Considering that Pearl was only 16 at the time, and his sister only about 10, the land was likely purchased by their father and put in their names. The purchase price was \$325.00. In 1939, Pearl sold his share of the land to his sister, Erma for \$1.00.

As a young man, Pearl worked for Peter Moll, a blacksmith on Seneca St. in Fountain Hill (est. 1913). Later, Pearl was employed by the the railroad at the Bethlehem Steel Co. In the 1930's he began to experience health problems, which the doctor told him was because of "floating kidneys". At this time he went to work at he Open hearth furnaces at the steel and continued to work there until he retired. He was also a volunteer firefighter. In his spare time, he enjoyed going to the auto races.

Pearl had a very nice singing voice and would always listen to German hour on the radio and sing along with the music. He also enjoyed playing the harmonica and would sit out on the bench under the apple tree in the backyard with his sons and play his favorite songs.

Throughout his life, Pearl owned a variety of different cars, including Ford Model T's, Dodges, and Touring Cars.

Obituary-Bethlehem Globe Times

Pearl U. Danner, 43, of 18 Warren St., Fountain Hill, died yesterday in St. Luke's Hospital. He was the husband of Mrs. Agnes M. (Richter) Danner.

Danner was a helper in No. 1 open hearth furnace at Bethlehem Steel Co.

Born in Walnutport, he was a son of the late William and Mamie (Reppert) Danner.

He was a member of Liberty Fire Co. Bethlehem and Seidersville Democratic Club.

Surviving besides his wife are four sons.

James L., William, Joseph, and John, and a daughter, Anna, wife of Paul Gross, all at home; a sister, Erma, wife of Victor Troxell, Milton, Northumberland County, and 12 grandchildren.

Notes for AGNES MARIE RICHTER:

Agnes grew up in a poor German Catholic family in a small rented house in Fountain Hill. She was one of seven children.

As a child, Agnes became very sick one year near Easter time and nearly died. Her family started calling her "Bunny". It was a nickname that her family and friends would use for the rest of her life.

Agnes had her first child, Joseph, out of wedlock, because her parents refused to let her marry a man who was of Hungarian ancestry. She married Pearl Danner when Joseph was less than one year of age. Although Joseph was never formally adopted, Pearl always treated him as if he were his own son.

As a twin, Agnes and her sister, Lizzie often had identical tastes in clothing. Agnes's daughter recalls one occasion when she and her mother were shopping for a dress to wear to a funeral. Agnes found one she liked and bought it. When she wore it to the funeral, she saw her sister had on identical dress! It turned out that Lizzie had even bought her dress at a completely different store.

As she got older, Agnes became a little eccentric about some things. She especially liked to hide money because she thought someone would steal it from her. But her choice in hiding places were often a bit bizarre, such as when she hid some money in the toaster. The money was discovered when her daughter-in-law, Connie, made toast and the money caught on fire!

Agnes was also known to tell people that nobody gave her any food. She would sometimes go to visit her granddaughter, Judy, at the bottom of Warren St. and say that nobody had fed her!

Mrs. Agnes Marie Danner, 85 of 18 Warren St., Fountain Hill, widow of Pearl U. Danner, died yesterday at St. Luke's hospital.

Born in Bethlehem, she was the daughter of the late Louis and Caroline (Wein) Richter.

A member of St. Ursula Catholic Church, Fountain Hill, she formerly held membership at Holy Ghost Catholic Church, Bethlehem, and was a life member of Seidersville Democratic Club.

Surviving are four sons, Joseph P. and James L. both of Fountain Hill, William C. of Bethlehem, and John of Salisbury Township; a daughter, Mrs. Paul Gross with whom she resided; two sisters, her twin, Mrs. Elizabeth Miller of Fountain Hill and Mrs. Caroline Eck of Allentown, 14 grandchildren and 18 great-grandchildren.

Marriage Notes for PEARL DANNER and AGNES RICHTER:

Pearl and Agnes were married by W.F. Bower, Alderman on 3 May 1915. They were re-married in Holy Ghost Catholic church on 11/26/ 1932.

Pearl and Agnes raised their family in their home at 18 Warren St. in Fountain Hill. The home was purchased in 1917 by Pearl's father, William, and bequeathed to them in his will. Pearl and his sister, Erma, also inherited a vacant lot in the city of Allentown. This land was seized by the Tax Bureau in 1950 for nonpayment of taxes.

After Pearl's death in 1957, Agnes lived in the Warren St. home for the rest of her life. Her daughter, Anna, moved in to the house with her family.
